(i) Details of investigation done by anti ragging committee members

- Thanks for your email. I once again thank this helpline for bringing the case to our knowledge.
- 2. After waiting for your response to know the name of candidate and waiting for the student to approach me or our Anti-ragging member(s), we started our inquiry from the students named in your email. These students live outside the college campus in rented accommodation. During the inquiry it surfaced that there is a student by the name Mr. Rahul Sawal, who lives along with them in the same premises, has slight stammering. But the students named in your email have denied their involvement in any kind of ragging.

However, they have pointed out that Mr. Rahul Sawal, who hails from Konkan region, believes that all the residents of the premises laugh at him or talk about him only.

- 3. After speaking to the students named in your email we tried to contact Mr. Rahul Sawal but he had gone to his native place on 25 January (working day for college) because 26 28 January 2018 were holidays. I personally spoke to Mr. Rahul on mobile and confirmed that he was the student, referred to as victim, in your email. He told me that his cousin living in someplace in Gujarat had lodged the complaint online even though Mr. Rahul wanted to meet the Principal first.
- I told Mr. Rahul to contact the Principal on 29th January 2018 after returning from his native place. He came to my cabin and we spoke at length about what exactly had happened. Mr. Rahul gave his version. Mr. Rahul also mentioned about another student who was his batchmate during their Diploma and who was his room partner here initially. When I spoke with Mr. Rahul's this former room partner he told me that he had to leave the company of Mr. Rahul because of his suspecting nature and attitude.
- 4. We also spoke to Mr. Rahul's cousin, who has lodged the complaint, and tried to understand the ratioale behind his action. He admitted that he should have first sent Mr. Rahul to Anti-ragging committee of college or to the Principal. This round about way of Resolving the matter could have been avoided, had Mr. Rahul Sawal approached his Head of Department directly or to the Anti-ragging committee or the Principal.

5. Any ways, we have spoken at length with Mr. Rahul Sawal, his cousin, his first roommate, and all the students named in your email. All the students are decent and have good track record. They are here for studies. Living together in hostel or in a hostel like premises has its own merits and demerits. They need to learn the art of living together by understanding each other and respecting shortcomings and good things of each other. No one is born perfect.

6. We have cautioned all the students, named in your email, to refrain from any act that could go against them. We have also advised Mr. Rahul Sawal to mix with others and enjoy this life. And we have told Mr. Rahul to come directly to me at the slightest feeling of ragging by anybody.

As such, as far as the college is concerned, the matter has been given due importance and views of all concerned students have been heard and they have been counselled appropriately. We do not think there is any more action needed at this stage. **Therefore, the case is closed from our end.**

It would be proper and prudent to advise anybody who lodges a 'complaint' on your helpline to first approach the Anti-ragging committee of college or the Principal of the college before approaching a third party. Because, otherwise, the very purpose of having an Anti-ragging committee or a Principal in an institute is defeated.

We thank you for your cooperation.

(ii) Conclusions of the investigations

a) The complainant ('helpline' did not reveal the name but we identified him to be Mr. Rahul Sawal) resides outside the college premises and hostel, along with about 15 – 20 others in rented accommodation with canteen facility. He suffers from slight stammering. He thinks that the students talk about him and if they are laughing then they are laughing at him.

b) Even though the students named in the complaint (received through 'helpline') have denied their involvement, the Principal and Anti-ragging committee have warned them and advised them to be careful in future. If they are found to be troubling the complainant in any manner then strict action would be taken.

c) The complainant has been advised to mix with his batchmates of the hostel where he resides (outside the college campus). He has also been advised to first approach his Head of Department (Mechanical Engg) or any member of Antiragging Committee of College or directly the Principal in future if there is any attempt by anyone to harass him or to trouble him in any manner.

This is with reference to a complaint from your classmate that cash of about Rs.600 was missing from his valet after the last examination on 19 December 2017 of previous semester. While going for the examination in the afternoon slot on 19 December 2017 he had kept his valet in his bag which was left on first floor of Bhaskaracharya building of MPCOE.

An inuity was conducted by a team of our faculty members and CCTV footages were checked. You were found to be opening the bag, carrying it to nearby washroom, and then replacing it. Your actions and movements were suspect. But since you were not available for inquiry we waited till 12 February 2018. Even though the college has officially started on 8th January 2018 and your classes of current semester started from 15 January 2018, you reported to college nearly a month later. We called up you and your parents a couple of times for inquiry but we did not get satisfactory response.

When the inquiry committee questioned you about the whole incident on 12 February 2018, you admitted to having opened the said student's bag and removing the valet. Even though you have denied removing the cash, the fact remains that the cash was missing and nobody else had touched the bag after you replaced it. Money is still missing as far as the student is concerned.

On the basis of your admission of opening the student's bag, we consider it a serious matter and we believe that if we do not take appropriate action then the credibility of institute will be at stake.

Considering all the above facts of the case, the motive, and your admission of the theft, you are suspended from college for a period of 4 days from 5th March to 8th March (both days inclusive). You will not be able to attend lectures and laboratory sessions on these days. Note that we have delayed the suspension to enable you to write your Internal Unit Test – I which was conducted during 27 Feb. to 1 March 2018.

Please note that if you fail to satisfy the minimum attendance norm of University of Mumbai in the current semester due to late reporting and suspension, and are detained, then you will be solely responsible for it.


